

"What's Your Eco-Score?" Prize Draw

Rules and Regulations

Agreement:

These rules govern the "What's Your Eco-Score" prize draw (also referred to as the "draw" or "contest"). The Eco-Score quiz and draw is operated by BurlingtonGreen Environmental Association (the "Sponsor"). No purchase is necessary to enter the draw. The act of entering the draw constitutes acceptance of these draw rules and the decision of the final draw for a winner(s) of the prizes shall be final and binding upon all entries.

Each entrant (and his/her legal guardian, if applicable) accepts and agrees to these Rules and Regulations.

If an entrant is under the age of 18 on the date of entering the contest and taking the Eco-Score quiz, the entrant requires his or her parent's or legal guardian's authorization before participating in the contest and accepting a prize as awarded.

Eligibility:

The prize draw is open to people of all ages, provided they are a resident of **Halton Region** (Ontario, Canada). Employees or Directors of BurlingtonGreen and their household family members are ineligible for the prize draw. Those involved in creating and administering the Eco-Score quiz tool and draw are also ineligible. Providers of sponsorship or prizes for the Eco-Score tool or draw, and their employees and any of their household family members, are also ineligible for the prize draw. People that are ineligible are still welcome to take the Eco-Score quiz; they just won't be eligible for the prize draw.

Winners of an Eco-Score grand prize in previous years are also ineligible for the prize draw, in order to give other participants a fair chance to win.

How to participate:

After reading the Eco-Score introductory web page (<http://www.burlingtongreen.org/eco-score>) which explains the quiz, contest and rules, proceed to the following web page and enter your name, email address, and city/town. Then, take the quiz. Your information will be saved and entered into the draw. Your email information will only be used by BurlingtonGreen for the purposes of this quiz and contest. We may send you an email after a period of time reminding you to take the Eco-Score quiz again and see how your score has improved. You will be entered into



the contest a second time, improving your chances of winning. Please **wait at least 30 days** before re-entering the contest, to avoid a disqualified contest entry. Contest entry and prize draw is based on *participation* in the quiz and is not dependent on your resulting score obtained on the Eco-Score quiz.

Draw period and details:

The draw entry period begins at 12:01 a.m. on **April 01, 2020** and closes at 11:59 p.m. on **January 15, 2021**. People who sign in and meet eligibility requirements and then proceed to complete the "What's Your Eco-Score?" quiz, will be entered into the draw for a chance to win the available prizes. Individuals may only use one valid email address and can complete the quiz a **maximum of two times** within the draw period, with entries required to be **at least 30 days apart**.

Any person who is found to have signed in and entered the draw with more than two entries received by such person during the draw period will have those additional entries disqualified. Any draw entries found to have been entered less than 30 days since the previous entry by that person will be disqualified.

Proof of transmission (screenshots or captures, etc.) or attempted transmission of a submission or of attempted submission of any communication, does not constitute proof of delivery or receipt by the draw computers. Registrations and entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. The Sponsor will not be responsible for late, lost, illegible, falsified, damaged, misdirected, mutilated, garbled or incomplete entries, which will be void. All entries become the property of the Sponsor upon receipt and none will be returned.

After contest close, all eligible entries will be collected, one name/entry will be drawn for the available prize and the winning individuals will be contacted by e-mail to confirm their acceptance of the prize and answer a mathematical skill testing question without assistance of any kind, whether mechanical or otherwise. In the event that a selected entrant incorrectly answers the mathematical skill-testing question, he/she will be disqualified and another entrant will be randomly selected and the above process will be repeated. This process will be repeated until such time as there are confirmed prize winners, and/or no more eligible entries are available.

In the event the person whose name/entry was drawn cannot be reached by **February 15, 2021**, the entry will be forfeited and a new name will be drawn from the collected entries.

Prizes:

The prizes must be accepted as awarded, are non-transferable and are not convertible to cash. The prizes are awarded as-is and no warranties or guarantees are implied or expressed, beyond the standard manufacturer's warranties where applicable.

Award of Prize:

All winners must have resided in Halton Region at the time of taking the quiz. Prizes will be delivered via email to the selected winners. Prizes must be claimed by **February 15, 2021**. If the winner does not claim the prize by that time, the entrant selected will have no further claim to the prize.

Release:

Prior to receiving the prize, the winner will be required to sign a declaration of eligibility confirming compliance with the rules and consenting to the use of his or her name and photo in any publicity carried out by BurlingtonGreen.

If the winner was under the age of 18 at the time of contest entry, a parent or guardian must also sign the release form. The signed release form must be received within one week of notification or the prize may be forfeited and awarded to an alternate entrant. Before the prize can be awarded, the recipient must also answer a skill testing question.

Privacy:

We use your personal contact information to administer the quiz and draw, including contacting, announcing and promoting the prize winner. We may send you an email reminder after about 6 months to take the quiz again and see how your score has improved. The draw is run in compliance with the BurlingtonGreen privacy code.

Banning:

BurlingtonGreen may in their sole discretion, prohibit any person from entering the contest whom it believes to be abusing the rules. Such abuse includes entering false information or entering the contest numerous times over and above the two allowed during the draw period.

Other:

The odds of winning depend on the number of eligible entries received. This draw is governed by the laws of Ontario and the laws of Canada applicable therein and is void where prohibited by law. BurlingtonGreen reserves the right to cancel or modify the draw or the draw rules at any time without notice.

HOW TO SHARE: During the draw period, entrants can: (i) share his/her “Eco-Score” results on his/her Facebook timeline or (ii) post a Tweet to his/her Twitter account or selecting a combination of the above during the draw period. To “Share” you will need to log into your Facebook® or Twitter account first and you will then be asked to confirm that you want to “Share” your results post on your Facebook® timeline or on your Twitter® account. If you want to limit the visibility of the “share” post on your Facebook® timeline, you can hide the post or make it visible to certain people (see “Share Policy”, below).

SHARE POLICY: “Friends” are those with whom the entrant has a personal/professional relationship and who are eligible to enter the draw. While you can “Share” the post to your timeline for your Facebook® friends or Twitter® followers to see, you should only “Share” with those who you have a personal/professional relationship and who are eligible to enter the draw. **Reminder**, prior to sharing with a friend, you must first obtain the permission of that person. The onus of obtaining such consent rests entirely with the entrant. The Sponsor assumes no responsibility for obtaining any such consent. CONDITIONS OF ENTRY: By entering the Contest, entrants (i) acknowledge compliance with these Official Rules including all eligibility requirements, and (ii) agree to be bound by the Official Rules and by the decisions of the independent contest organization and/or Sponsor, made in its sole discretion, which shall be final and binding in all matters relating to this Contest. Entrants who have not complied with these Official Rules will be disqualified.

If a dispute arises regarding who submitted an on-line registration or entry, the registration and entry will be deemed to have been submitted by the authorized account holder of the e-mail address provided at the time of entry. An “authorized account holder” is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. An entrant may be required to provide proof that he/she is the authorized account holder of the e-mail address associated with the registration and entry.

GENERAL: The Releasees do not assume any responsibility and are not responsible for: (i) the incorrect or inaccurate capture of entry information; (ii) entries which fail to comply with the Official Rules; (iii) any loss, damage, or claims caused by the awarded Prize or the draw itself; (iv) any failure of the website during the Draw Period, including any problems, human or technical error, printing errors, lost, delayed, or garbled data or transmissions, omissions, interruption, deletion, defect or failures of any telephone or

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrants and the Sponsor in connection with the Draw, shall be governed by, and construed in accordance with, (i) the laws of the Province of Ontario and construed in accordance with the Federal, Provincial, and Municipal laws applicable therein in respect of residents of the other Canadian provinces, without regard to conflicts of law principles. Any attempt by a participant or any other individual to deliberately damage any website or undermine the legitimate operation of the Draw may be a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. This Draw is subject to all applicable Federal, Provincial, and Municipal laws. PRIZES ARE AWARDED "AS IS" WITHOUT ANY EXPRESS OR IMPLIED REPRESENTATIONS OR WARRANTIES WHATSOEVER BY THE SPONSOR OR PRIZE PROVIDERS, INCLUDING WITHOUT LIMITATION ANY WARRANTY AS TO MERCHANTABILITY OR FITNESS FOR INTENDED PURPOSE.

The Sponsor reserves the right to terminate or suspend this Draw or to amend the Official Rules at any time and in any way, without prior notice, for any reason whatsoever. Without limiting the foregoing, if for any reason the Draw is not capable of running as originally planned, for example as a result of tampering or infection by computer virus, the Sponsor reserves the right, to terminate the Draw and conduct a random draw from all other eligible entries received prior to the termination of the Draw.

1. **INDEMNIFICATION BY ENTRANT:** By entering the Contest, each entrant releases and holds the Sponsor and Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant, or any other person, including personal injury, death or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, participation in this Draw, any breach of these Official Rules, or in any prize-related activity.
